- C. A handout of all previous Section 1 and Region A NIAAA Board members was distributed.
- D. The Section 1 Treasurers Report was discussed. Our ending balance as of 5/22/13 is \$9,195 (Motion Sargent/Dozibrin to maintain dues at \$200 per delegate per state passed unanimously) (Motion Dozibrin/Hingston to order more Section 1 pins passed unanimously)

- E. Section 1 Hospitality Suite New Jersey was officially thanked for their continued coverage. Rhode Island is offering to assist again. Published times worked well. (Motion to continue the suite Fell/Hingston passed unanimously)
- F. Dave Martens/Bob Lahey Scholarship of \$250 to assist states in getting people to the National Conference was discussed. (Motion to continue with the scholarship Hingston/Huestis passed unanimously)
- G. Collect State Data (use form) A form was circulated updating state data and forwarded to the NIAAA
- H. States Selecting Delegates to Delegate Assembly
  It was requested that states appoint delegates who will not have conflicts with the LTI classes which are offered at the same time. Please check the schedule and have them commit ahead of time.
- I. Contact Information on all attendees was collected.
- III. Review NIAAA Board of Directors and At-Large Rotation in your Section The Handout was discussed. Maine is next in rotation and they are currently involved in the selection process to be their candidate for the section 1 representative. The Section 1 At- Large Candidate for a region A election will be decided at this meeting. Qualifications in by-laws for these positions were provided.
- IV. Current Business
  - A. Section 1 At Large Nomination Process was presented and discussed. (After a few edifications a Motion was made Sargent/Shambo passed unanimously). See attached. Further discussion resulted in a request to add wording to the criteria process we already had established requiring candidates to submit a resume at least 30 days in advance on the section 1 meeting. (Motion Dozibrin/Fries passed unanimously). As a result of these discussions we will work on a Complete At-large nomination document which will include all previous historical data in addition to the new process and the changes to the criteria.
    - 2. Nomination Following the new procedure we established, two candidates were introduce-Robert Rossi, NJ and Peter Shambo, NY. Both gentlemen were allowed to speak and then asked to leave the room.
  - 3. Selection After a lengthy discussion and a vote both gentlemen were asked to return to the room. (Motion Ryan/Sargent placing <u>Robert Rossi</u>, CMAA from New Jersey into nomination for the Section 1 candidate for the Region A At-Large election in December 2013. Passed unanimously)
  - B. Scholarship Program a scoring tabulation sheet was distributed and the winners for Section 1 will be Katrina Lapham, Maine and Matt St. Amour, Vermont.
    - a. Sharing on how this is done in states:
      - VT has 10 state winners and selects from that pool
      - CT has changed the submission date to Jan. 31 so the recipients can attend their awards banquet to receive a state gift or \$500
      - RI uses 4 readers who forwards the results to the liaison for tabulation.
      - A request was made to edit the form to include all 3 scores of the SAT. Math, Verbal and Written should all be on the form.
      - Next year, a check list will be sent out with state submissions so all applications are complete.

C. Selection of Frank Kovaleski Professional Development Award – two names still remained the pool and this is their last year. Gary Stevens, Me. and Don Webster, NY. A vote was taken and the name of Gary Stevens, Maine will be submitted for the section 1 candidate for the award.

D. Section 1 Summer Institute – This is the 10<sup>th</sup> year and it continues to financially support itself. No further contracts with the hotel have been entered into as of yet.

- E. NIAAA 2013 Board Goals were in the notebook and reviewed.
- F. NIAAA Presentation Staff/Officer
  - 1. Membership/Member Benefits Section 1 was commended for all states having dual membership. Everyone should try and increase membership. The NIAAA currently has 8750.
  - 2. Budget the income is up 5% and projected expenses is below what was expected by 3.8%. The endowment has \$835, 520.
  - 3. Conference The schedule was reviewed. A sixth workshop session was added.
  - 4. Textbook is on schedule and the final cost should be under \$40.
  - 5. NFHS Coaches Education/Certification- courses were reviewed.
  - 6. Advocate Report FLSA The handout was explained and the advocate's goals were reviewed.

7. Products/Services for Members/Schools- the various agencies/companies that can benefit the membership was discussed

8. Adaptive Sports/Unified Sports- The different programs that exist were discussed and all should support these programs in their states.

- 9. LTC 621 will continued to be offered at the national conference
- 10. Misc. PSA's are doing extremely well.
- G. Section 504 of Rehabilitation Act 1973 (ADA Act)- The "Dear Colleague" letter from the OCR and the Q&A were discussed. The NIAAA plans to offer workshops on this as well as make available all their resources to the membership.
- H. Professional Development Update:
  - 1. State Professional Development (LTI/Certification) Coordinators Meeting was reviewed/
    - a. Indianapolis, Indiana Sept. 7 9, 2013 Crowne Plaza Hotel, Airport
    - b. The NIAAA will pick up cost of one room for each state in addition to food costs.
  - 2. New Courses in Development
    - a. 627 will be downsized Strength & Conditioning Programs
      LTC 627 content is the administration of the facility and program specific to AD's (all technical content to be removed and inserted into new course, LTC 628)
    - b. LTC 626 Student Health Issues (Still in development will not release in 2013)
    - c. 710A Module Accommodations for Disabled Student Athletes will be a topic
  - 3. 2013 Course Revision
    - a. 719 was started in February (ready for December, 2013)
    - b. 625, 709, 724 and 799 will be started in July (625 and 799 ready for December, 2013)
  - 4. University Degree Programs- The NIAAA has agreements with the following Universities who are using NIAAA materials in their degree or certificate programs.

- 7. Professional Development Task Force A study of the current model is underway and recommendations for improvements will be made including marketing strategies.
- I. Committee Reports/Items
  - 1. Committee Applications- The form to join a committee is online as well as a list of members who serve on the committees. It was requested the application form have a spot for the state leadership to sign off on before an application could be processed.
  - 2. Vice Chair Application- people should indicate a desire to serve in a leadership role.
  - 3. Reports committee updates were provided.
    - a. Awards- Cass Herbst will end her term as chair at year's end. Susan Robbins was appointed Chair, Sean Moore as one vice-chair. A second vice-chair is needed.

b. Coaches Education – A strategies and benefits document is being created to highlight the importance of continuing education and certification. Foundations course has been updated.

c. Credentials- exploring electronic voting. Committee would like percentage of those voting to increase from the current response of 58-59%

d. Endowment – A golf tournament will be held in Anaheim. The Silent Auction will take the place of the golf tournament at the 2014 National Harbor conference.

e. Hall of Fame – Nominations due July 1. Committee will meet in August to review 2014 nominees.

f. NEN – National Emergency Network – seeking hotel partnerships to aid stranded members. Bill Mayo has been extended one more year as Chair.

g. Publications – Profile of Athletic Administration being revised. The IAA is 5 issues ahead with articles.

h. Sports Turf - working to find other instructors for the LTI

- K. Endowment- discussed in committee report and budget
- L. 2013 Hall Fame Class-was reviewed
- M. Fourth Strategic Plan Committee In February 2014, the board will identify individuals to be solicited to serve on the 4<sup>th</sup> Strategic Planning Committee (2016-2020). Between now and February, state should solicit individuals who might have an interest in serving. Names should be sent to Trish Witkin. Committee will meet in Indianapolis in October 2014 and again at the 2014 National Harbor conference. The current plan concludes at the end of 2015.
