III. Upcoming Board Positions Review: Trish Witkin of Connecticut will replace Frank Pecora

Discussion about By-law changes to amend the by-laws to add one at-large member to the board of directors and eliminated the current at-large election process. Four regions on a rotation basis, without any elections, would replace the current configuration of regions A, B & C. Fred spoke of being against this and Denny Fries supported it. Alan Mallanda asked "if it ain't broke don't fix it". This proposal came from Section 8. The rationale is to eliminate the need for raising funds for election of at-large members. Place the selection of board members in the hands of Sections where the person is best known. Carol Dozibrin brought up the issue that when an at-large election came up with a person who was running form a region was where the conference was being held, it was tough. Scott Fitzgerald brought up putting the voting on line so that the entire membership would have the opportunity to vote. General consensus was not in favor of this by-law change. Fred mentioned that his opinion was that many Presidents have come from the at-large position.

- D. Staff/Officer Presentation: President Annette Scoggins spoke of NIAAA Face Book Page. Mike Blackburn spoke that goal of NIAAA is to have 100% membership Nationwide. Spoke that all of Section 1 is dual membership and he spoke highly of this. NIAAA goal is to serve AD's. CT, NH & RI are 100% or higher. States in Section 1 with 80%, NJ, NY. Annette Scoggins spoke on Leadership Training- 721 Positive Sportsmanship, 627 Weight training & conditioning are new LTI courses. Mentioned that accreditation has been attained for LTI program. This will pay-off as a respect factor for the Organization. NIAAA has sent out press releases, it is on the web site. This has allowed continuing education credits for the AD's in Texas to be given at their conference. Things will have to be kept up with each year on the accreditation. Gerry Durgin will be the chair of that committee. Alan Mallanda is on that committee from

Section 1. They will begin in July at the regular Board Meeting. Mike spoke of going over seas with Countries that are interested in LT courses. Don Bayles went to Budapest to teach courses. Much talk of accreditation being under an umbrella to cover all States Boards of Education. Annette spoke of coaching education/certification program. In July the Board will move on having a position of a Program Director of Certification with hire in 2012. Gerry gave kudos to Mike & Bruce Whitehead for all their work on the daunting task of achieving accreditation. Speaking on Budget Mike spoke of the cost of achieving everything on the Strategic Plan. Had a deficit of \$38.000 for the past year. This prompted the \$80 dues increase as the first one in 10-11 years. Showed a profit from the Conference in comparison to a loss of 2009. Should make \$60,000 from this year's conference. A budget is now being built every year for the Conference by both the NFHS & NIAAA. Have maintained an emergency fund as deemed by the Strategic Plan. Regular dues have that Life Insurance takes up 14% of dues. IAA magazine last year had a cost \$4.20 per member. It is now making a profit per issue instead. Talk of putting the IAA magazine as an electronic copy at some point. Mike asked about turning over the information to the general public? No consensus. Time frame. There are about 400 subscribers that aren't members currently. Conference schedule- 91 workshop topics to be refined down to 35. They will repeat some workshops, something that has been requested. Most evals say that #1 is sharing of ideas with AD's #2 workshops, #3 LTI courses. Relationship workshops ones are the most popular. Going to offer less time in Exhibit Hall, just two days. Just Sat. & Sunday for now. First General speaker is Joe Theisman and he will be moved to the Exhibit Hall. There will be forums in the exhibit hall. Five sessions of workshops over three days. Lee Green will be a general session speaker. Tab #10 showed financial report of the NIAAA budget reimbursement. Section meeting 11:15-11:45 on Sunday. Speaking of a watch for conference gift. New sponsors- Give someone a \$30,000 grant to put in new track. Digitaltown bought up every school website across the country and give some money to each school from advertisements. E-news is going out to membership, with happenings in your State. All NIAAA Forms are now PDF and fillable format. Misc. After July meeting there will be information about student-Athlete College Fairs.
