Professional Development

The Professional Development Leadership Team met with Telspan to examine the possibility of administering an electronic CAA exam. Telespan is a current provider for the NIAAA and has the capability of providing the service with varied amounts of amenities. It is important to note that the opinion of the membership is not necessarily in favor of online testing. However, as technology drives more and more of our everyday lives, it behooves this organization to move in a more efficient and "green" direction. Therefore, The Professional Development Leadership Team is asking the NIAAA Board of Directors to approve the mandatory use of an electronic exam that is administered by a Certified Test Administrator. Although this is not a complete transition to a true online test, it does address the concern of security and meets our goal of efficiency and paper free. These actions will initiate the "first steps" to an online environment. We hope to pilot a practice CAA exam in September 2015 and announce the change to the membership in December 2015 with total integration in December 2016.

Leadership Training Institute

The length of LTI Courses will is being examined. Some courses will continue to run for four hours. However, there will be consideration to change the length of some courses to three hours. TheFuture courses may include a Drug and Alcohol class and a Nutrition Class.
