## NIAAA Board of Directors October Conference Call Meeting Highlights

The NIAAA Board of Directors met via conference call on October 18, 2016. Among the highlights:

- 1. The Board reviewed the current financial report as presented by Executive Director Mike Blackburn.
  - a. Income and expenses indicated in the report also include funds for the National Conference for Directors of Athletics the NIAAA has responsibility for managing the collection and disbursement of funds for this event this year.
  - b. Actual total income for the year is 10% above projections. Certification income is 27% behind projections, but Leadership Training Institute income is up by 44% (\$32,716).
  - c. The Endowment Fund is down from the same point as last year as there is no golf tournament or fun run this year at the National Conference.
  - d. Reserve Fund assets are up \$439,736, including \$269,900 transferred from the checking and savings funds during the year
  - e. In general, financial reports are tracking as expected.
  - f. Currently income exceeds expenses by \$178,599.
- 2. At the July meetings, the Board of Directors authorized the NIAAA staff to expend surplus money from last year's budget towards specific projects to benefit the association and its membership. Mike Blackburn reported that the Learning Management System (that will support on-line CAA and other LTI initiatives) has been purchased as well as some needed office equipment and software.
- 3. The NIAAA POP Manual has been loaded onto the NIAAA Portal and reflects changes made by the officers.
- 4. The Board of Directors approved the following committee appointments:
  - a. Certification Vice-Chairs Tol Gropp (Idaho) and Jacob von Scherrer (Florida)
  - b. Sports Turf Jonathan Vincent (Kentucky)
  - c. Currently all committee membership and officer slots have been filled.
- 5. The Board of Directors approved a series of professional grant and outreach applications submitted by state athletic administrator associations
- 6. Washington-Lee High School in Arlington, Virginia was approved for an NIAAA Quality Program Award.
- 7. The Board discussed new federal guidelines regarding the Fair Employment Standards Act. (New guidelines exist regarding levels of salaried workers exempt from the 40-hour overtime statutes.) Staff salaries and work schedules have been adjusted to be in compliance with this law.

- 8. The Board of Directors will be meeting at the National Conference for Directors of Athletics in Nashville. The group reviewed the schedule for those meetings and Board activities during that event.
- 9. NIAAA President-Elect Rich Barton of Utah reported on the recent Leadership Training Coordinators meeting in Indianapolis. 47 states were represented at this event, and several new or refurbished courses (LTC 510, 610, 715) were piloted. There was also discussion about potential content for new courses. Dr. Jarrod Spencer (Mind of the Athlete) was also in attendance and spoke to the group.
- 10. The NIAAA is ready to begin on-line testing for the CAA exam at the National Conference. The program will be piloted in Nebraska and Ohio prior to that event.
- 11. A number of schools in the country are piloting eRecruit. More information will be available about his product in coming months.
- 12. Mike Blackburn and Phil Rison talked about the NIAAA's insurance coverage and how it impacts liability at NIAAA events.

In addition, four athletic directors from the section will receive NIAAA Distinguished Service Awards at the conference banquet scheduled for Tuesday, December 13.

NIAAA Past President and former New York athletic director Dennis Fries will be inducted into the NIAAA Hall of Fame. Denny, who is retired as athletic director of Irondequoit High School, is his state's liaison to the NIAAA and has been important voice in our section and throughout the country for many years. Denny was co-founder of the Section 1 Summer Institute and has presented multiple times at national conferences. He has been a leader in utilizing technology to enhance the work and performance of athletic directors. Denny is a very deserving recipient of the association's highest honor – our section is proud of and salutes you!

Susan Robbins, athletic administrator in Yarmouth, Maine, has been selected to receive the Thomas E. Frederick Award. Susan is the chairperson of the NIAAA Awards Committee and a former Associate Director in the Maine Interscholastic Athletic Administrators Association. Congratulations also go to Susan on this recognition for her service to the student-athletes of her school, state, and the country in general.

Four Section 1 leaders will receive NIAAA Distinguished Service Awards at the conference banquet. Michael Lunney of Rhone Island will be joined on the stage by Peter Shambo (New York), Josh DiColo (New Jersey), and Todd Sampson (Maine). Lunney was a section representative on the NIAAA Board of Directors while Shambo is currently the co-director of the Section 1 Summer Institute. Both DiColo (Publications) and Sampson (Credentials) are committee chairs. Congratulations to all of these deserving individuals from your section colleagues!
